

### SCHOLARSHIP Committee.

Held a successful 2019 W. A. Pattillo Alumni Christmas Ornament fundraiser. Reviewed current processes and procedures used to select scholarship applicants. Named the 2020 W. A. ## **The Trailblazers Award Celebration**

Originated in late 2019, the Community Trailblazer Award recognizes, celebrates, and honors an individual or a group, alive or deceased, who has made a significant contribution to the East Tarboro/Princeville communities through special involvement or outstanding achievement in specific areas of the community and/or professional life.

The three recipients were the Honorable Mayor James "Ed" Bridgers, former mayor of Princeville, the Honorable Mayor Delia Wood Perkins, former mayor of Princeville and Mr. Bernard Dunn a past resident of Tarboro who currently resides in Princeville. Mr. Bridgers was acknowledged for his long-standing service to the Towns of Princeville and Tarboro. Former Mayor Perkins was, too, recognized for her longstanding service to the Princeville community and service as its Mayor. Mr. Dunn was acknowledged for his advocacy for youth, specifically for the creation of a mentoring program that seeks to enhance the development and growth of young African American males.


### **BENELOVENCE** Committee.
